Regular City Council Meeting of March 11, 2019

The City Council of the City of Princeton, Texas, met in regular session in the Council Chamber of City Hall on March 11, 2019 at 6:30 p.m.

The following Councilmembers were present: Councilmember David Kleiber,
Councilmember Nikki Krum, Councilmember Richard Sheehan and Councilmember
Steve Deffibaugh. Mayor John – Mark Caldwell was present. The following was absent:

Mayor Caldwell called the City Council Meeting to order at 6:30 PM.

Mayor Caldwell called roll, present were Councilmembers David Kleiber, Nikki Krum, Richard Sheehan and Steve Deffibaugh.

Todd Boady, Pastor of First Christian Church, led the audience in the invocation.

Councilmember Krum then led the audience in the Pledge of Allegiance.

Mayor Caldwell then announced Citizen Appearance. No one spoke under citizens appearance.

Mayor Caldwell then announced the Consent Agenda: All consent agenda items listed are considered to be routine by the City Council and will be enacted by one motion. There will be no separate discussion of these items unless a Councilmember so request, in which event the item will be removed from the Consent

Agenda and considered in its normal sequence on the agenda. Items on the Consent Agenda were: Discussion and possible action regarding the minutes of the February 11, 2019, Regular City Council meeting; Discussion and possible action regarding the City of Princeton 1st Quarter Financial Report FY 2018-19." Mayor Caldwell advised the minutes on the Consent Agenda were for the February 25, 2019 City Council Meeting. There was a typo of February 11, 2019, however the minutes attached to the agenda were for the February 25, 2019 meeting. Councilmember Deffibaugh made a motion to approve the Consent Agenda with the change of date to the minutes of February 25, 2019. Councilmember Krum seconded the motion to approve. The motion carried unanimously.

Mayor Caldwell then announced the first item under the Regular Agenda:

(2019-036) "Discussion and Possible action regarding an Ordinance of the City of Princeton amending the Comprehensive Zoning Ordinance Number 2016-01-25-01 of the City of Princeton from "SF-2", Single Family Residential to "PD17" Planned Development 17, on a Portion of the Hardin Wright Survey, Abstract No. 957; Repealing all Conflicting Ordinances; Providing a Severability Clause; Providing for a Penalty; and Providing an Effective Date." Councilmember Deffibaugh made a motion to approve. Councilmember Sheehan seconded the motion to approve. The motion carried unanimously.

Mayor Caldwell then announced the second item under the Regular Agenda:

(2019-037) "Consideration and action on Resolution 2019-03-11-R-02 approving the

Brookside Public Improvement District Preliminary Service and Assessment Plan,
including a proposed assessment roll; calling a Public Hearing to consider an ordinance

District; and resolving other matters incident and related thereto." Councilmember

Deffibaugh made a motion to approve. Councilmember Kleiber seconded the

motion to approve. The motion carried unanimously.

Mayor **Caldwell** announced the meeting would have a small break to obtain signatures on item 2019-038 that was just approved. Break started at 6:37 p.m. Break ended at 6:38 p.m. Meeting reconvened at 6:38 p.m.

Mayor Caldwell then announced the third item under the Regular Agenda:

(2019-038) "Discussion and consider all matters incident and related to the issuance and sale of "Greater Texoma Utility Authority Contract Revenue Refunding Bonds, Series 2019 (City of Princeton Project)," including the adoption of Ordinance, 2019-03-11, approving the issuance thereof and the refunding of certain outstanding bonds of the Authority." Councilmember Deffibaugh made a motion to approve.

Councilmember Sheehan seconded the motion to approve. The motion carried unanimously.

Mayor Caldwell then announced the fourth item under the Regular Agenda:

(2019-039) "Possible action to approve request for items to be placed on a future agenda and NOT for discussion of these requests." Councilmember Deffibaugh requested discussion for City Council Meeting times to be on the next agenda.
